

2024 Andy Grammer VIP Package Sweepstakes

Official Rules

NO PURCHASE NECESSARY: No purchase of any kind is necessary to enter or win. Making a purchase will not increase your chances of winning. Void where prohibited by law. This sweepstakes is subject to all applicable federal, state, and local laws.

ELIGIBILITY: Sweepstakes is open to legal residents of the United States who are 18 years of age or older at the time of entry. Employees of Susan G. Komen ("Sponsor") and its respective officers, directors, parents, subsidiaries, affiliates, as well as their immediate family members, are not eligible to enter or win. Entrants may need to provide proof of residency. All entries should be submitted in good faith.

HOW TO ENTER: Sweepstakes period is September 4, 2024, at 12:01 am CST through October 13, 2024, at 11:59 pm CST. Entrants may complete a donation on [Komen.org/Andy](https://www.komen.org/Andy) during the sweepstakes period to enter. The amount of the donation determines the amount of entries:

- One hundred (100) entries for a \$10 donation;
- Two hundred fifty (250) entries for a \$25 donation;
- Three hundred fifty (350) entries for a \$35 donation;
- Six hundred (600) entries for a \$50 donation;
- Seven hundred fifty (750) entries for a \$75 donation;
- One thousand (1,000) entries for a \$100 donation;
- One thousand five hundred (1,500) entries for a \$150 donation, and
- Two thousand five hundred (2,500) entries for a \$250 donation.

If you donate an amount not stated on the chart above, you will receive the number of entries stated on the Sweepstakes Website prior to finalizing your donation. (In most cases, the number of entries is 10 times the amount of the donation.) All donations are final and nonrefundable.

For alternate means of entry, an individual may send an email to Sponsor and include within the email the name of the Giveaway, "2024 Susan G. Komen Andy Grammer VIP Package Sweepstakes," the statement "I acknowledge that I have read, understand and agree to the Sweepstakes Official Rules, "individual's first name, last name, phone number and a valid email address by October 13, 2024 at 11:59 pm EST. Limit one alternate means of entry per individual. Alternative means entries will receive the number of entries equal to the highest individual number of entries.

Entries must be complete to be eligible.

PRIZE DESCRIPTION: One winner will receive two (2) tickets to the Andy Grammer "Greater Than: A One Man Show" concert in Boulder, Colorado at Boulder Theater on Sunday, October 20, 2024, at 8:00 pm GMT. Prize also includes a meet and greet with photo opportunity with Andy. The approximate retail value of the prize is \$200 USD. Travel to the event, airfare, accommodations, and other costs associated with attending the event are not included in the prize.

WINNER SELECTION: All eligible entries submitted during the sweepstakes period will be entered into a drawing on October 14, 2024. One (1) winner will be randomly drawn from all eligible entries. Odds of winning depend on the number of eligible entries received for the sweepstakes.

WINNER NOTIFICATION: The winner will be notified via the phone number and/or email address provided to the Sponsor in the winner's entry. To claim the prize, the winner must accept the prize within twenty-four hours of the first notification by Sponsor. If the winner fails to claim the prize within 24 hours, declines the prize, or fails to comply with these official rules, the winner will be disqualified from receiving the prize. In the event that a potential winner is disqualified for any reason, Sponsors will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Only three (3) alternate drawings will be held, after which Sponsor reserves the right to not award the prize. Within twenty-four hours of acceptance, Sponsor will provide winner's name to "will call" for ticket pickup on the night of the concert. It is the winner's sole responsibility to access the tickets from "will call" in order to gain entry to the concert. Winner becomes the official winner only after their eligibility has been confirmed by Sponsor and they have received notification from the Sponsor confirming their prize.

GENERAL TERMS & CONDITIONS: All entrants must meet the eligibility requirements set forth in these Official Rules in order to qualify for the prize. By participating, each entrant agrees to:

- (1) Abide by these Official Rules and decisions of Sponsor, which shall be final in all respects relating to this sweepstakes;
- (2) Release, discharge and hold harmless Sponsor, and its respective parents, affiliates, subsidiaries, and advertising and sweepstakes agencies, and the respective officers, directors, shareholders, employees, agents and representatives; and

If for any reason the sweepstakes is not capable of running as planned, Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the sweepstakes and select winners from among all eligible entries prior to the cancellation. Persons found tampering with or abusing any aspect of the sweepstakes, or whom Sponsor believes to be causing malfunction or error, disruption or damage will be disqualified. Sponsor reserves the right to correct any typographical, printing, computer programming or operator errors.

Sponsor is not responsible for any entry that is lost, late, illegible, stolen, mutilated, incomplete, invalid, unintelligible, postage-due, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, human error, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer transmissions, typographical or system errors and failures, faulty

transmissions, technical malfunctions, or otherwise. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsors.

Prize cannot be resold, traded, or auctioned and has no cash redemption equivalent. Prize cannot be utilized for any promotional, marketing or advertising purpose other than for Susan G. Komen. Prize cannot be "scalped" or used for any illegal purposes.

If the actual value of a prize is less than previously stated, the difference will not be awarded. Other restrictions may apply. All prizes are subject to change and/or cancellation. An IRS Form 1099 for the fair market value of the prize will be filed and a copy provided to each winner. Each winner must provide Sponsor with his or her social security number so that the Form 1099 can be provided. Without limitation, Sponsor shall not be liable for any failure to deliver prize due to winner's failure to accept delivery, to meet any of his or her obligations hereunder or due to the submission of any false, inaccurate or misleading information.

YOU HEREBY WAIVE ALL RIGHTS AND RELEASE EACH OF THE RELEASED PARTIES FROM ANY CLAIM OR CAUSE OF ACTION, WHETHER NOW KNOWN OR UNKNOWN, OF ANY KIND, INCLUDING BUT NOT LIMITED TO DEFAMATION, INVASION OF RIGHT TO PRIVACY, PUBLICITY OR PERSONALITY OR ANY SIMILAR MATTER, RELATING TO THE SWEEPSTAKES, THE OPERATION THEREOF, OR ANY SUBMISSION, OR BASED UPON OR RELATING TO THE USE AND EXPLOITATION OF THE ENTRIES AS CONTEMPLATED HEREIN, OR USE IN SWEEPSTAKES SITE FORM, EITHER INTENTIONALLY OR OTHERWISE. YOU HEREBY REPRESENT AND WARRANT THAT YOU HAVE READ THESE OFFICIAL RULES AND ARE FULLY FAMILIAR WITH THEIR CONTENTS.

All judgments or awards shall be limited to actual out-of-pocket damages (excluding attorneys' fees) associated with participation in this sweepstakes and shall not include any indirect, punitive, incidental and/or consequential damages.
