

Official Sweepstakes Rules

ShareforCures® Registration Sweepstakes

NO PURCHASE NECESSARY: No purchase of any kind is necessary to enter or win. Making a purchase will not increase your chances of winning. Void where prohibited by law. This sweepstakes is subject to all applicable federal, state, and local laws.

ELIGIBILITY: Sweepstakes is open to residents of the United States who are 18 years of age or older at the time of entry.* Employees of Susan G. Komen ("Sponsor") and its respective officers, directors, parents, subsidiaries, affiliates, as well as their immediate family members, are not eligible to enter or win. Entrants may need to provide proof of residency. All entries should be submitted in good faith.

*Individuals in Alabama and Nebraska must be over 19 and individuals in Mississippi and Pennsylvania must be over 21 to participate in ShareForCures.

HOW TO ENTER: Sweepstakes period begins at 11:59 pm CT on September 16, 2024 and will end at 11:59 pm CT on October 7, 2024.

When you are fully enrolled as a ShareForCures participant by the time the sweepstakes period ends, you will be entered for a chance to win a prize. Full enrollment requires registering and creating a user account, agreement to the informed consent and medical release, and complete response to questions about you and your breast cancer history. Failure to fully complete these steps will result in disqualification from this sweepstakes. Existing fully enrolled individuals in ShareForCures at the beginning of the sweepstakes period will be automatically submitted to the sweepstakes.

For alternate means of entry, send an email to Sponsor and include within the communication the full name of the sweepstakes, the statement "I acknowledge that I have read, understand and agree to the Official Rules," first name, last name, phone number, email address, and home address. Entry must be received no later than one week prior to the end of the sweepstakes period to be eligible.

Entries must be complete to be eligible. Limit one entry per individual.

PRIZE DESCRIPTION(S):

There will be 3 winners of this sweepstakes. The first winner will receive one (1) gift card in the amount of \$50. The second winner will receive one (1) gift card in the amount of \$100. The third winner will receive one (1) gift card in the amount of \$150. Gift cards are redeemable via Prezzee for a limited selection of available retailers.

WINNER SELECTION: All eligible entries submitted during the sweepstakes period will be entered into the drawing taking place after the sweepstakes period. Three (3) winners will be randomly drawn from all eligible entries. The odds of winning depend on the number of eligible entries received for the sweepstakes. Limit one (1) prize per individual.

WINNER NOTIFICATION: The winner will be contacted via the email address provided to Sponsor in the winner's registration. The winner will automatically be emailed the prize and claim it upon receipt. Failure to timely claim the prize within three (3) business days after the first notification by Sponsor will

result in disqualification. If a potential winner is disqualified for any reason, Sponsor may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. It is within the discretion of Sponsor to select alternate winner if the prize is unclaimed/forfeited but is not required to do so. Once the prize is claimed, the prize will be emailed to the winner within ten (10 business days.

GENERAL TERMS & CONDITIONS: All entrants must meet the eligibility requirements set forth in these Official Rules in order to qualify for the prize. By participating, each entrant agrees to: (1) Abide by these Official Rules and decisions of Sponsor, which shall be final in all respects relating to this sweepstakes; (2) Release, discharge and hold harmless Sponsor, and its respective parents, affiliates, subsidiaries, and advertising and sweepstakes agencies, and the respective officers, directors, shareholders, employees, agents and representatives; and (3) Acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding.

Any attempt by an entrant to obtain more than the stated number of entries by using multiple/different identities, and/or any other methods will void that entrant's entry and that entrant may be disqualified from the sweepstakes.

If for any reason the sweepstakes is not capable of running as planned, Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the sweepstakes and select winners from among all eligible entries prior to the cancellation. Persons found tampering with or abusing any aspect of the sweepstakes, or who Sponsor believes to be causing malfunction or error, disruption or damage will be disqualified. Sponsor reserves the right to correct any typographical, printing, computer programming or operator errors.

Sponsor is not responsible for any entry that is lost, late, illegible, stolen, mutilated, incomplete, invalid, unintelligible, postage-due, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, human error, entries not timely received, lost or unavailable network connections, failed, incomplete or garbled computer transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsors.

Prize is awarded as is, has no cash redemption equivalent, and cannot be resold, traded, or auctioned. All incidental costs associated with use or redemption of prize is solely the winner's responsibility.

If the actual value of a prize is less than previously stated, the difference will not be awarded. Other restrictions may apply. All prizes are subject to change and/or cancellation. Winners may be required to provide Sponsor with an executed IRS form W-9 and social security number to accept their prize and may also be required to sign an affidavit of eligibility, liability release, and publicity release. When applicable, an IRS Form 1099 for the approximate retail value of the prize will be filed and a copy provided to each winner. In connection with any involvement and/or activities related to the prize, each winner does hereby: (1) Acknowledge and accept sole responsibility for all of the hazards and risks to him/herself and his/her property associated with or related to participation and for any damage, illness, or injury that he/she may cause to others; (2) Acknowledge and assume all risk and danger incidental to participation in events in connection with the prize; and (3) Release, waive and forever discharge any and all claims of damages or causes of action, including but not limited to, death, personal injury or loss or damage to property, which he/she or any of his/her representatives, heirs, next of kin or assignees (collectively "Representatives") may have or which may hereinafter accrue to him/her or his/her Representatives as a result of participating or otherwise which may be asserted by his/her or his/her Representatives against the Released, whether caused by the acts, omissions or negligence of the Released Parties or by any other person or entity.

Sponsor reserves the right to request from any entrant additional documentation it reasonably believes is necessary to validate any entry or to award the prize. Without limitation, Sponsor shall not be liable for any failure to deliver prize due to winner's failure to accept delivery, to meet any of his or her obligations hereunder or due to the submission of any false, inaccurate or misleading information.

ENTRANTS RELEASE OF LIABILITY AND WAIVER:

YOU HEREBY WAIVE ALL RIGHTS AND RELEASE EACH OF THE RELEASED PARTIES FROM ANY CLAIM OR CAUSE OF ACTION, WHETHER NOW KNOWN OR UNKNOWN, OF ANY KIND, INCLUDING BUT NOT LIMITED TO DEFAMATION, INVASION OF RIGHT TO PRIVACY, PUBLICITY OR PERSONALITY OR ANY SIMILAR MATTER, RELATING TO THE SWEEPSTAKES, THE OPERATION THEREOF, OR ANY SUBMISSION, OR BASED UPON OR RELATING TO THE USE AND EXPLOITATION OF THE ENTRIES AS CONTEMPLATED HEREIN, OR USE IN SWEEPSTAKES SITE FORM, EITHER INTENTIONALLY OR OTHERWISE. YOU HEREBY REPRESENT AND WARRANT THAT YOU HAVE READ THESE OFFICIAL RULES AND ARE FULLY FAMILIAR WITH THEIR CONTENTS.

PRIVACY: By participating in the sweepstakes, entrants hereby agree and acknowledge that personal information submitted with and in relation to an entry may be collected, processed, stored and

Should there be a conflict between the laws of the State of Texas and any other laws, the conflict will be resolved in favor of the laws of the State of Texas. All judgments or awards shall be limited to actual out-of-pocket damages (excluding attorneys' fees) associated with participation in this sweepstakes and shall not include any indirect, punitive, incidental and/or consequential damages.
